Governing Law: Arab Republic of Egypt

Welcome! We are honored to host you. Please read this carefully before participating in any activities.



1. Understanding the Risks

I understand that participating in activities arranged by Egyptian Grand Tours LLC involves inherent (natural) risks, including but not limited to:

-  Horse riding
-  Camel riding
-  Nile River boat excursions
-  Red Sea boat excursions
-  Scuba diving & snorkeling
-  Desert safari & off-road vehicles
-  Ground transportation

I acknowledge that:

- Animals may react unpredictably.
- Boats may encounter waves, wakes, or mechanical issues.
- Scuba diving carries pressure-related risks, marine life risks, equipment malfunction, and emergency limitations.
- Desert terrain may include shifting sand, uneven ground, and vehicle hazards.
- Injuries, including serious injury or death, although rare, are possible.



2. Voluntary Participation

I confirm that:

- I am participating voluntarily.
- I understand the risks involved.
- I accept full responsibility for my decision to participate.



3. Assumption of Risk

I knowingly and freely assume all risks, whether known or unknown, foreseeable or unforeseeable.



4. Release & Hold Harmless

To the fullest extent permitted under Egyptian law, I release and hold harmless:

- Egyptian Grand Tours LLC
- Its owners, guides, employees, contractors, drivers, boat operators, dive instructors, animal handlers, and affiliated service providers

From liability for injury, loss, damage, or death arising from participation, except in cases of proven gross negligence under Egyptian law.

5. Scuba Diving Declaration (If Applicable)

I confirm that:

- I am medically fit to dive.
- I hold proper certification OR understand I am under certified supervision.
- I understand risks including decompression sickness, drowning, marine life injury, panic response, and emergency evacuation limitations.
- I accept full responsibility for my participation.




6. Medical Responsibility

I confirm that:

- I am physically fit for participation.
- I carry personal travel/medical insurance.
- Egyptian Grand Tours LLC is not responsible for medical expenses.

7. Force Majeure (Events Beyond Control)

The company is not liable for events beyond reasonable control, including:

- Weather conditions 
- Sea conditions 
- Animal reactions 
- Mechanical issues not caused by negligence
- Government actions
- Civil disturbances
- Natural events ("Acts of God")

8. Governing Law

This agreement is governed exclusively by the laws of the Arab Republic of Egypt. Any disputes shall be resolved in Egyptian courts.
